Students with strong interest in the study of domestic violence and gender issues having either a Masters in Law or Social Sciences from any University/College of repute.

Responsibilities:

- Assist in collecting data through surveys, interviews, and focus group discussions with various stakeholders, including police officers, protection officers, victims, witnesses,

judges, public prosecutors, one stop centers, State Women Commission, Rangbah Shnongs and Dorbar Shnongs.

- Conduct fieldwork in the four districts (East Khasi Hills, Jantia Hills, Ri-Bhoi and West Khasi Hills) across the state of Meghalaya.
- Collaborate with the project team to organize and analyze the collected data.
- Prepare project-related documentation, sanction orders, tour diaries, reports, and presentations.
- Remuneration: Field researchers will receive a stipend of Rs. 50 per data point (exclusive of travel and food).
