1. Whether National Law University, Meghalaya is a Central University or State University or Autonomous Institution.

The National Law University of Meghalaya can be classified as a State Statutory University. It may be noted that as the National Law University of Meghalaya has been set up as per the – The National Law University of Meghalaya Act, 2022 (Act No. 10 of 2022), per the Government Of Meghalaya, Law (B) Department, Notification, No. LL(B).99/2011/Pt./270) published for general information under the Meghalaya Act No. 10 of 2022 as passed by the Meghalaya Legislative Assembly which has received the assent of the Governor on the 23rd September, 2022 which has also been published in the Gazette of Meghalaya Extra-Ordinary issue dated 27th September, 2022

- 2. As per Advertisement No.: NLUM/09/Estt/Adv./2022/84 Dated 14th April 2023:
  - a. Whether the position termed as Executive Assistant or Executive Officer (under Support Staff Category) is termed as Executive Assistant when, under DETAILS OF SUPPORT STAFF POSITIONS ADVERTISED, it's termed as Executive Officer.
  - b. What is the correct term for the said post?
  - c. The salary structure defined in the advertisement follows the salary structure as per the post defined under the Government of Meghalaya pay structure Level or Meghalaya High Court Salary structure Level.

As per the NLUM/09/Estt/Adv./2022/84 Dated 14th April 2023, the advertisement inadvertently listed the position as "Executive Assistant" with Pay Level L-18 and as per the section, "Details of Support Staff" the post has been defined as "Executive Officer" with classification "Tenure" and pay level: L-18 as per the Government of Meghalaya pay structure.

As per the university notification No. NLUM/Estt/Rec-EO/182/2023/808 dated Shillong 01<sup>st</sup> December 2023 being the result of the interview for the post and as per the decision of the University Selection Committee and other relevant University authorities, the post has been corrected as "Executive Officer" and the pay scale has been corrected as L-14 as per the Government of Meghalaya pay structure.
